IN CITY COUNCIL

June 23, 1980

ORDERED:

That in accordance with the provisions of the General Ordinances of the City of Cambridge, Chapter Three, Section 3-2, the Commissioner of Public Works be and hereby is authorized to grant a permit to Pier I Imports for the purpose of displaying merchandise on the sidewalk in front of the premises numbered 14 Eliot Street from June 23rd up to and including September 3rd from 10 a.m. to 7 p.m. Monday through Friday and 10 a.m. to 6 p.m. on Saturday provided that no such permit shall be granted to exceed more than twenty-five percent of the width of the sidewalk from the property line of the premises in front of which said display shall be installed and provided further that before erecting the above named display, the petitioner shall file with the City Clerk a satisfactory bond in the sum of Two Thousand Dollars (\$2,000) conditioned to save harmless the City of Cambridge from all claims for damages arising from the construction, maintenance and use of said display.
