ORDERED:

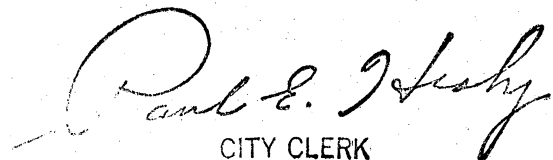

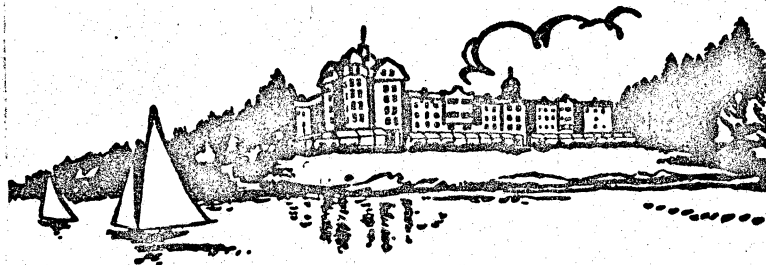

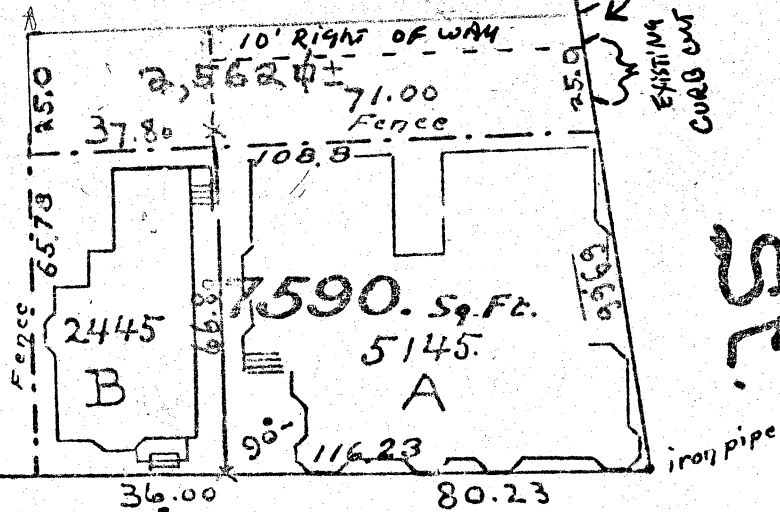
