Attached is an order requesting a transfer from the Police Department Salary & Wages Account \$132,700.00 to the Police Department Other Ordinary Maintenance Account \$26,700.00 and Travel & Training Account \$106,000.00. The increases in Other Ordinary Maintenance is to cover the increase in the new insurance contract related to coverage on marked vehicles. The Travel & Training increase is primarily in the damages account \$95,000.00 for medical expenses related to two on-the-job injuries.
