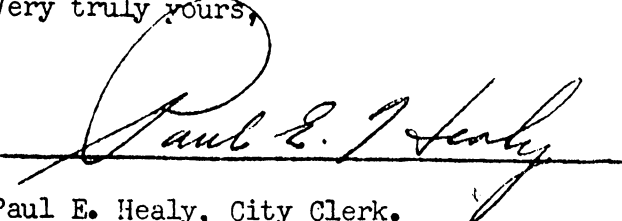
Enclosed herewith you will find the petition of Patrick J. and Mary J. Hickey

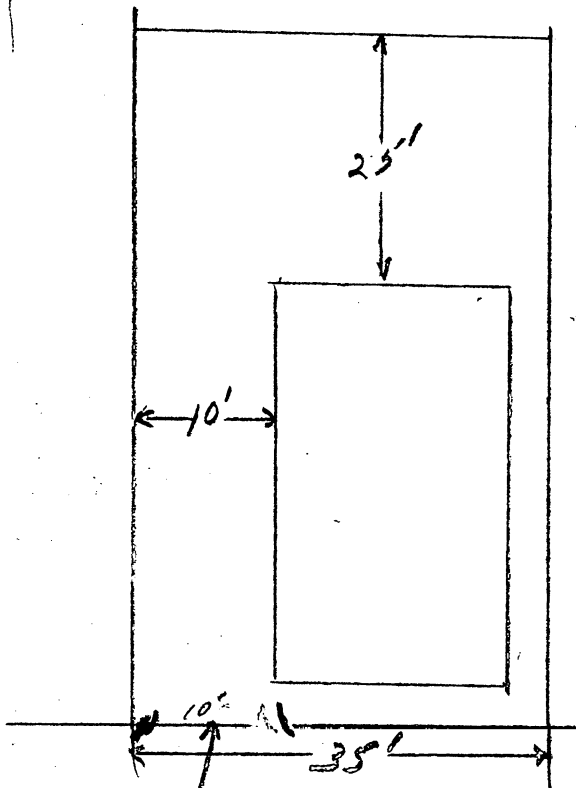

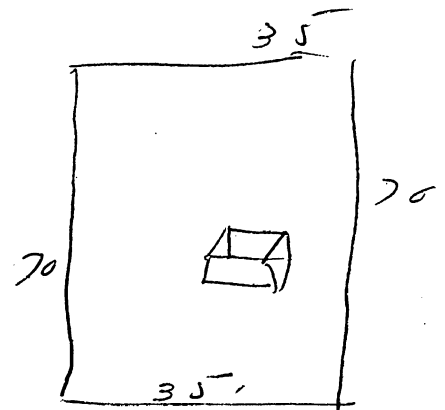
