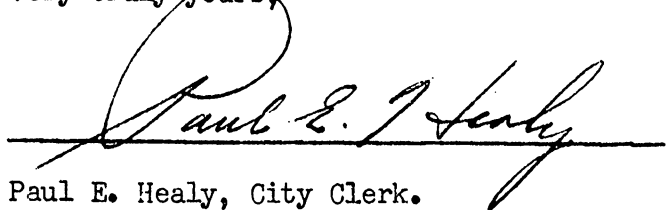

City of Cambridge:

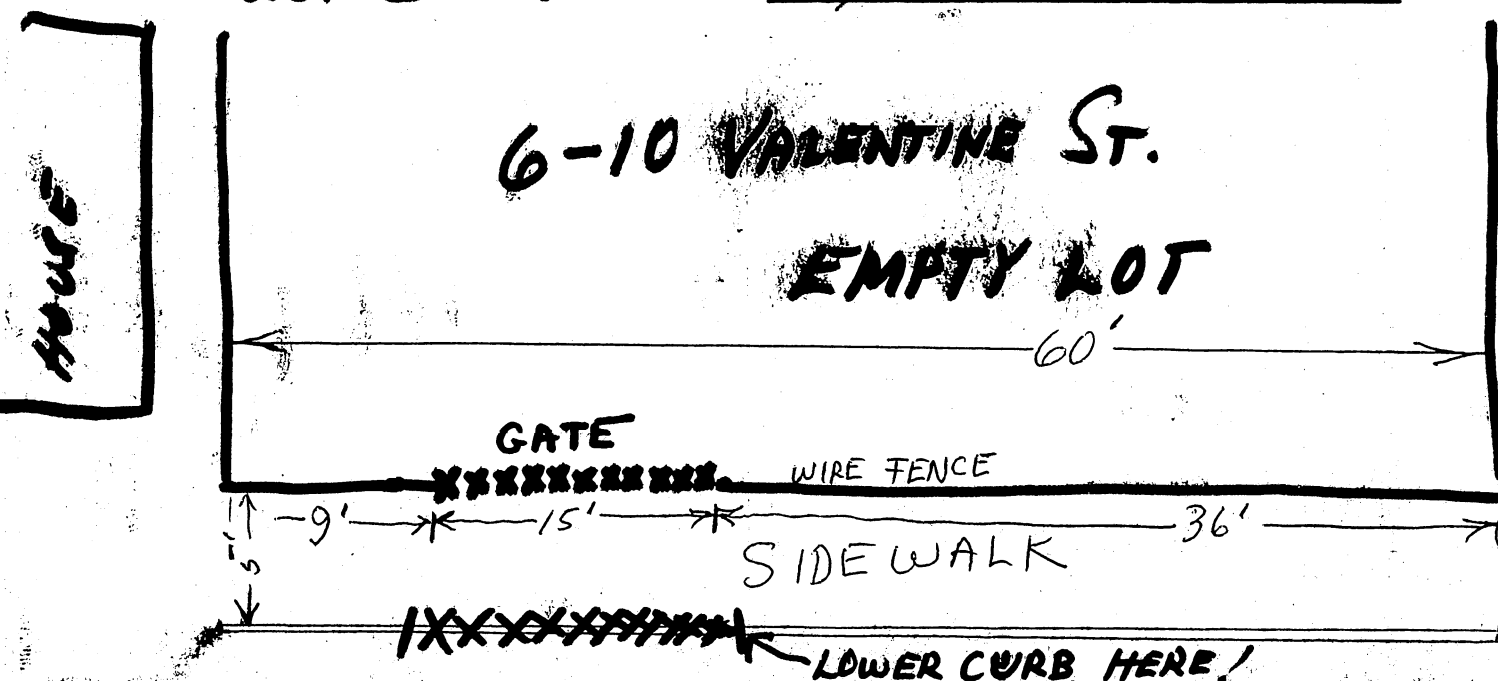
