

Dear Joe,

The Harvard Square Business Association would like to sponsor its first annual May Fair on the Cambridge Common on Sunday, May 6, 1984, from 12 noon until 6:00 p.m. (with a raindate the following Sunday, May 13th).


We propose to feature the international flavor of Harvard Square at an annual May Fair, by offering for sale international food and beverages (wine, beer, and soft drinks only), crafts, and clothing. The Business Association would provide appropriate entertainment in keeping with an international spring festival, and would ensure that the event was properly policed; that the Common was cordoned off from street traffic; that necessary permits were obtained from local authorities; that a central area near the statue be set with tables and chairs, and that sale of wine and beer be restricted to adults over the age of 21.

As a non-profit organization, the Harvard Square Business Association would charge admission and participant fees to help defray its costs. If successful, we anticipate that approximately 48 establishments (most of whom are members of the Harvard Square Business Association) will participate in the May Fair this year. Of these, we expect that 10-12 booths will sell wine or beer, 24 booths will sell food, and the other booths will offer items such as clothes, crafts, souvenirs, etc.) The Association will, furthermore, provide on-spot sanitation facilities, clean-up crews, supervision, and gate control.

We respectfully request permission to use the Cambridge Common, exclusive of the playing field, for our May Fair, Sunday, May 6th (or May 13th, in case it rains May 6th). We also request permission on behalf of our participants who wish to sell a variety of international food, wine, beer, and other goods.

We hope that you will grant our request to hold our first annual May Fair, and that you will be there on May 6th to help ensure its success and to help us celebrate spring in Harvard Square.


