Provided that, before erecting the above named awning the petitioner shall obtain a permit from the Inspectional Services Department and file with the City Clerk a bond in the sum of Two Thousand (\$2,000.00) Dollars, conditioned to save harmless the City of Cambridge from all claims for damages arising from the installation, maintenance and use of said awning.

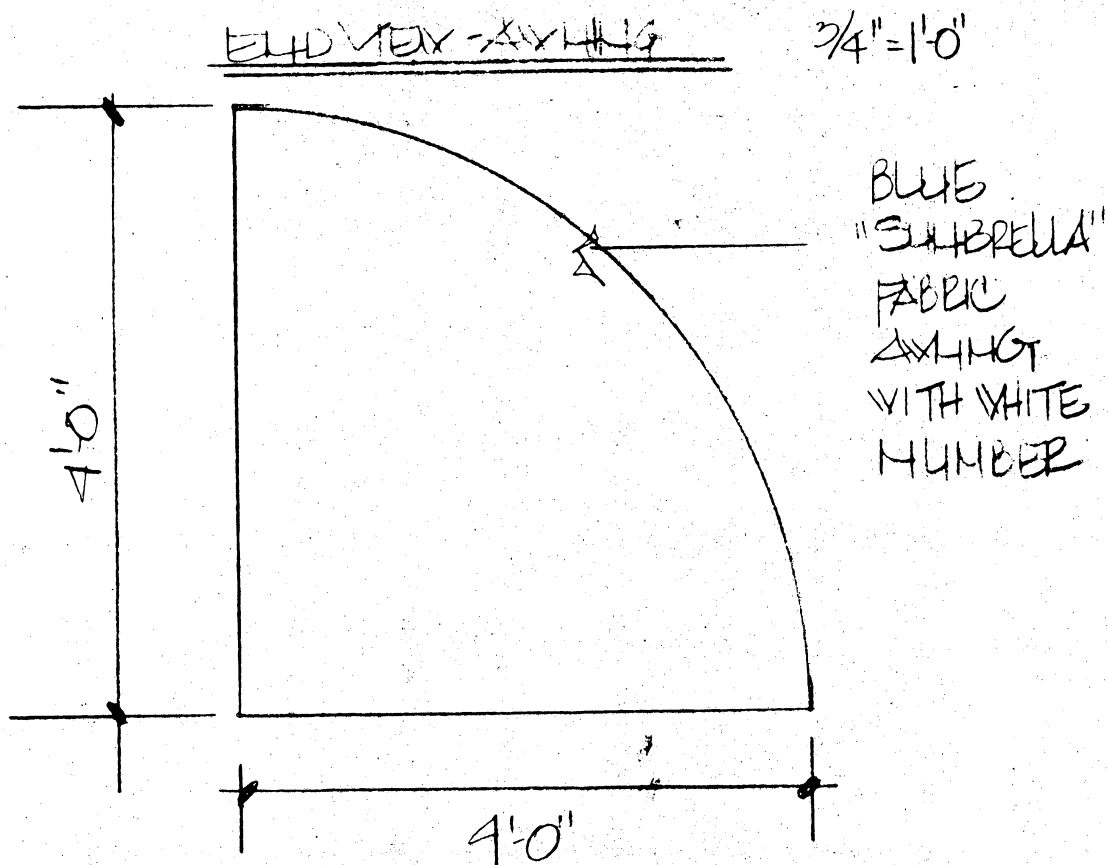
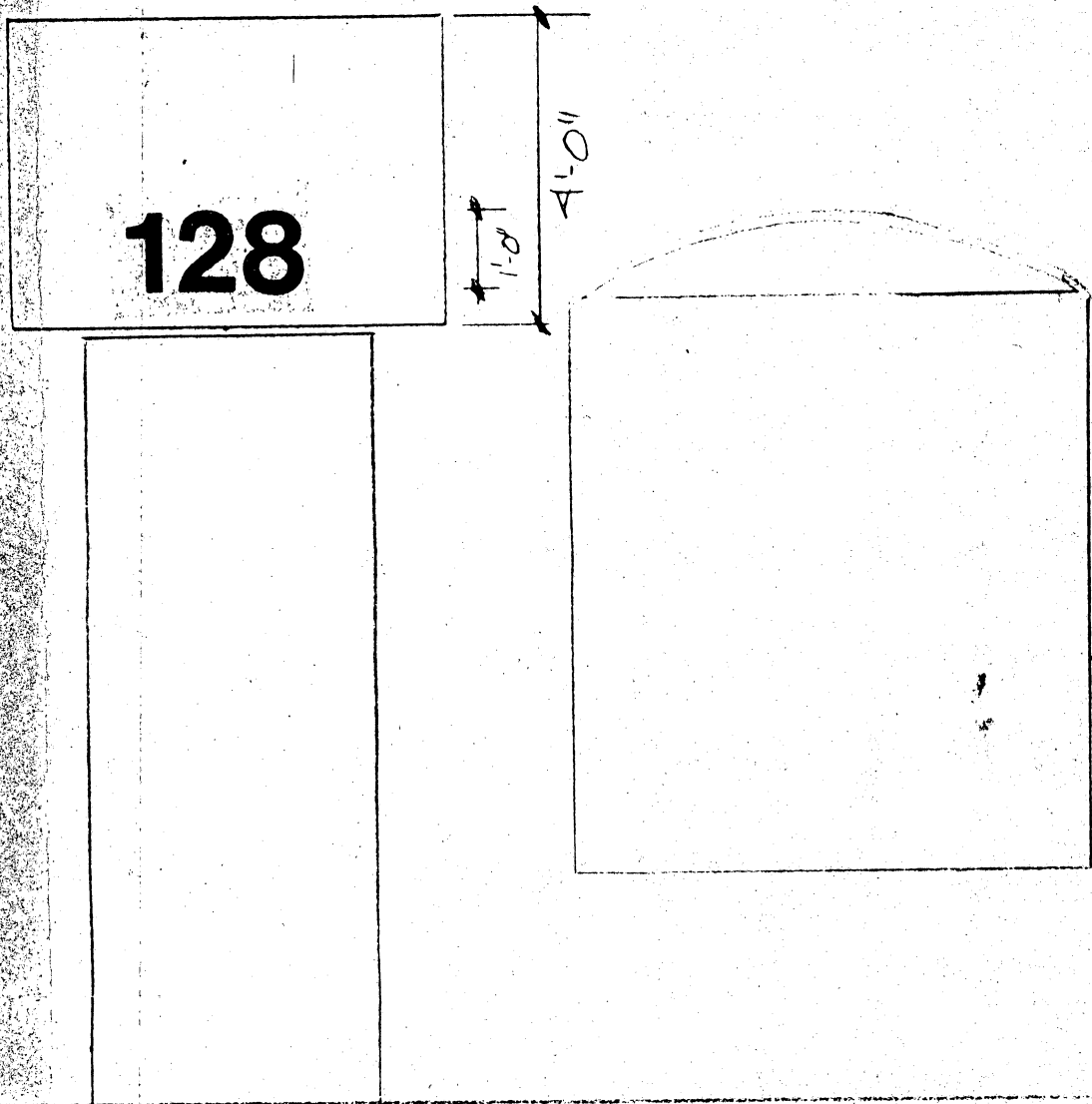

Authorization and Indemnification Agreement

MediSense, Inc., agrees that it will protect and indemnify the Massachusetts Institute of Technology (M.I.T.) and its agent, Meredith & Grew, Inc., and save M.I.T. and its agent and employees harmless from a and against all liabilities, obligations, claims, language, penalties, causes of action, costs and expenses (including, without limitation, attorneys' fees and expenses) imposed or incurred by or asserted against M.I.T., its agents or employees by reason of any accident, injury to, or death of persons or damage to or loss of property, by theft or otherwise occurring as a result of said signage and awning being affixed to said building, unless arising out of the negligence or willful misconduct of M.I.T. or its agents or employees. In case any action, suit or proceeding is brought against M.I.T., its agents or employees by reason of such occurrence, MediSense, Inc., upon M.I.T.'s request, shall at MediSense's expense, cause such action, suit or proceeding to be resisted and defended by counsel designated by M.I.T.

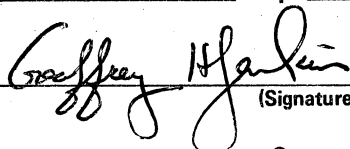
