USAGE may be for two or three types of business that has a
tendency to serve the public , This I can disclose later he
is interested to have your disposition in the matter as soon
as possible .

Both your records and mine will show that when Real Estate Was

submitted an other of \$ 30.000. And both these offers were

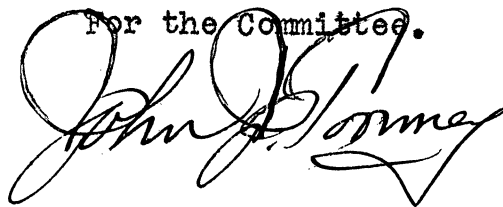
