ORDERED:

That, in accordance with the provisions of an ordinance relative to placing and maintaining signs, the Commissioner of Public Works be and hereby is authorized to grant a permit to Cherry Webb & Touraine ^{MARQUEE} for the erection of a ~~sign~~ at 38 Brattle Street.

Provided that, before erecting the above named sign, the petitioner shall obtain a permit from the Building Department and file with the City Clerk a satisfactory bond in the sum of Twenty Thousand Dollars (\$20,000.00) conditioned to save harmless the City of Cambridge from all claims for damages arising from the construction, maintenance and use of said ^{MARQUEE} ~~sign~~.

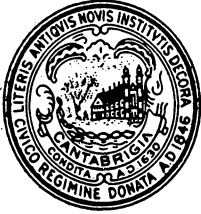

Subject Approval for Projecting Sign at 38 Brattle Street

On Monday, January 17, 1983, Councillor Duehay requested that Community Development review a petition from Cherry, Webb Touraine for maintaining an existing marquee which projects over the entrance of their store at 38 Brattle Street. I spoke with John Magnarelli of Cherry, Webb Touraine who informed me that the petition is required because the store in switching insurance agents must also obtain a new bond in order to continue to meet the City's requirements. In order to secure this bond, a new permit must be granted. No construction or additional signage is proposed.

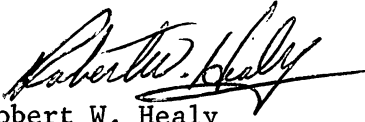
