

Proposal:

Encasing the base area of the public trash barrel located at the intersection of Cambridge, Hampshire & Springfield Streets, with a four sided enclosure. The enclosure will not interfere with the trash barrel's use and will be removable at all times.

Purpose:

To provide major street visibility for the Cafe and Bistro known as "Cafe Soho" during it's hours of operation.

Why an enclosure?

An enclosure of the existing barrel would provide minimum impact on the pedestrian flow of traffic. It would also blend into the neighborhood more unobtrusively than an "A" frame type sign.

Furthermore, the enclosure, by its nature, anchored around the barrel, creates a far less likely ability to impair or injure anything due to an unforeseen movement by strong winds or mischievous hands.

Liability:

A bond satisfactory to the City would be obtained and kept in force.

The Enclosure:

One side of the enclosure will be dedicated to a "Do Not Litter" campaign at all times. The other three faces will be focused on the location of Cafe Soho with highlights as to it's offerings (for example: on a Saturday or Sunday morning the sign will feature "Brunch"). The enclosure would only be out during the establishment's hours of operation.
