GREETING:

WHEREAS, the General Court at their previous session, enacted Chapter 1212 of the acts of 1973 adding the additional sum of seventy four thousand dollars, to be raised on the several cities and towns in this County, according to the directions of the law for defraying the usual necessary charges of the County; and

WHEREAS, the County Commissioners for said County of Middlesex, at a meeting holden at Cambridge, in said County, on the first Wednesday of January, A.D. 1974, and by adjournment thereof at Cambridge, on the sixteenth day of January, A.D. 1974, ordered that the Clerk of said Commissioners should forthwith issue warrant for assessing the several cities and towns their proportion thereof as the law directs, and for paying in the same;

THEREFORE, in the name of the Commonwealth of Massachusetts, you are ordered to assess each his due and equal portion thereof, as near as maybe, according to the rule for defraying the state and county charges, Viz, the additional sum of

Seven Thousand One Hundred Fifty-One Dollars and Forty-Seven Cents (\$7,151.47)

city
upon the inhabitants of the town of **CAMBRIDGE** being the said city's-
town's proportion for the additional County Tax in the proportion above
mentioned. And you are to commit to the collector, constable or constables
of your town, requiring them respectively to levy and collect the sum total
of the above amount of the County Tax so assessed upon the inhabitants there-
of. And, you are required to pay, or issue your warrant to the treasurer
of said town requiring him to pay to the Treasurer of said County as follows:
the balance of one-third $1/3$ of the proportion equal to

One Million Eighty-Three Thousand One Hundred Thirty-Eight Dollars and

Sixty-Eight Cents (\$1,083,138.68)

previously billed on order dated November 21, 1973 plus the said additional
assessment which equals a total sum of

One Million, Ninety Thousand Two Hundred Ninety Dollars and Fifteen Cents

(\$1,090,290.15)

due on or before May 1, 1974
