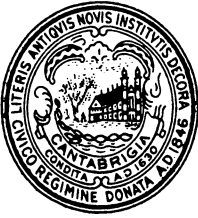


\$5,200.00 to F-7 - Non Contributory Pension, to provide pension for Forrest L. Gould who has retired from the position of Clerk of Committees.
