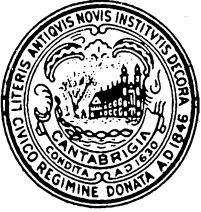


To the Honorable, the City Council:

The attached appropriation of \$1,000 to the Community Schools Other Ordinary Maintenance account is funded by two \$500 grants.
