Attached is an order requesting the appropriation of \$303,434 in Interest Earnings on Chapter 90 funds to the Public Investment Fund Extraordinary Expenditure Account, which, when combined with \$211,796 in previously appropriated Chapter 90 funds, will provide a total of \$515,230 to fully reconstruct Bishop Allen Drive from Main Street to Inman Street.

It is expected that this work will be completed by the end of the summer of 1990.
