This transfer is necessary to provide for the anticipated Bills for repairs made to equipment in the office.

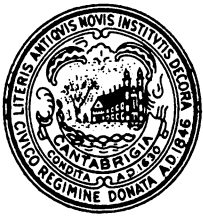


