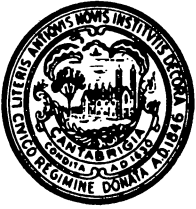

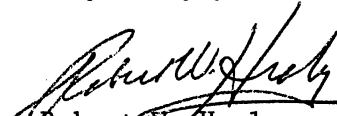
To the Honorable, the City Council:

Attached is an order requesting the acceptance and appropriation of a grant from the Massachusetts Department of Mental Health for FY88 in the amount of \$884,241.00 to the Health and Hospital Services Salaries and Wages account (\$591,150.00), and Other Ordinary Maintenance account (\$293,091.00) to provide funds for the operation of a secure unit for mentally ill women at Metropolitan State Hospital

This grant is for the first year of a three-year renewable term award and will be used to provide clinical and forensic evaluation and short-term treatment for mentally ill women who are involved with the criminal justice system.
