To The Honorable, The City Council:

Attached is an order requesting the appropriation of \$250,000.00 to the Public Works Department (Snow Removal) Other Ordinary Maintenance Account. The FY94 snow removal account has been exhausted due to the heavy snow fall during the last few months. The additional appropriation, primarily will cover expenses already incurred over the budgeted allotment for chemicals, sand, garage parts and the contracting of additional plows. Funds will also be used for the purchase of an additional 1,000 tons of chemicals.

It is important to note however, that I may be recommending a second appropriation during this fiscal year for snow removal pending weather conditions during the remaining winter months. This appropriation will be financed from free cash.
