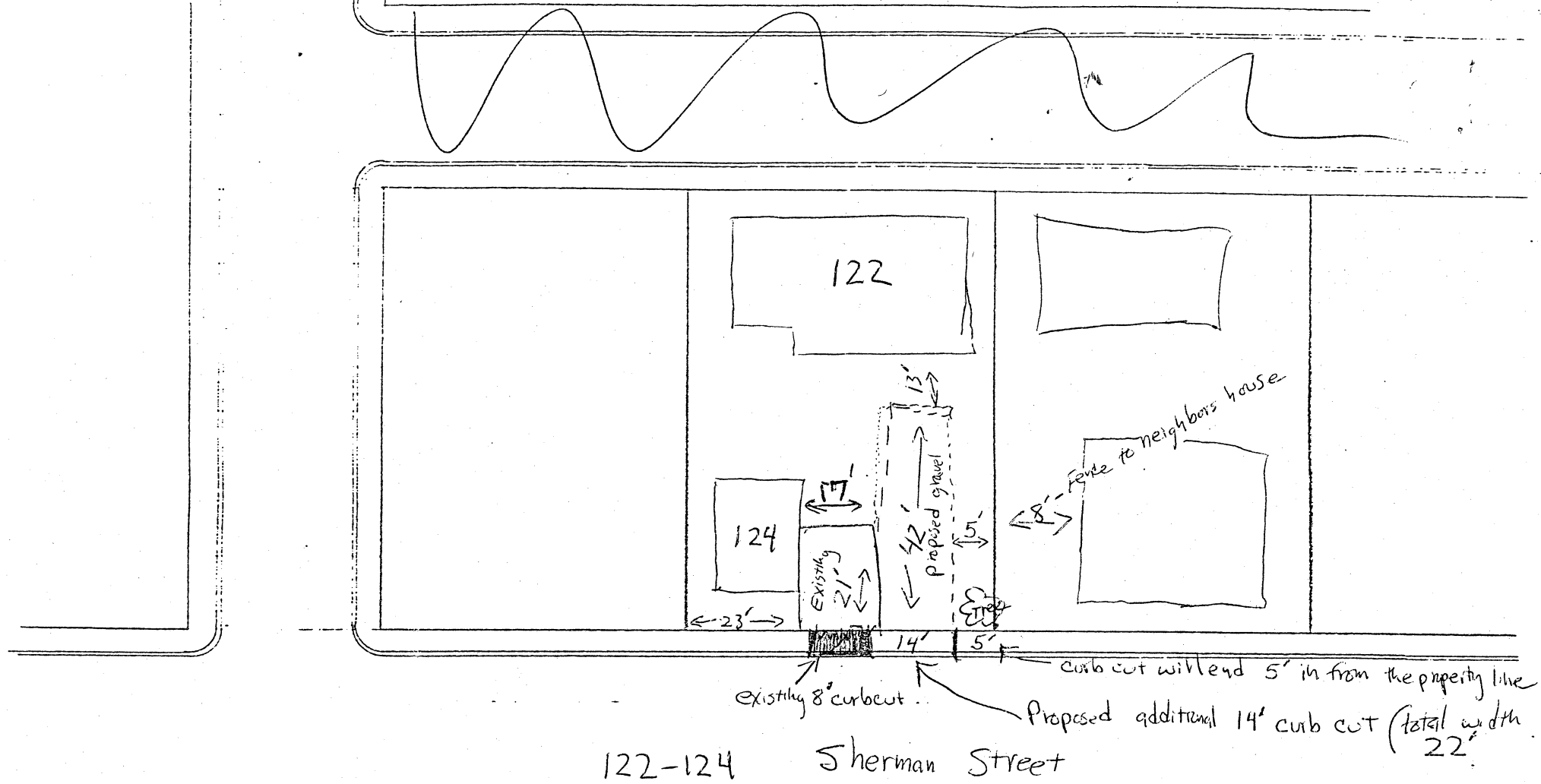

- 1) address of proposed curb cut
- 2) frontage
- 3) setback
- 4) block & lot
- 5) demensions of proposed driveway

- 7) Location of any sign posts, fire hydrants, utility poles, etc..., in the direct vicinity of the proposed driveway
