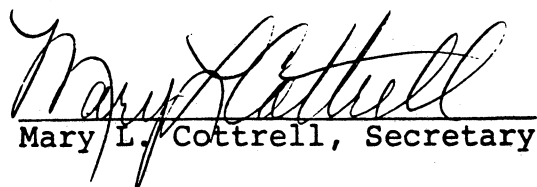
Application and Petition of the Cambridge Electric Light Company, pursuant to G.L. Chapter 164, Section 14, for approval and authorization to issue and sell up to 104,000 shares of common capital stock, \$25 par value, at no less than par; to issue and sell, on a negotiated basis, additional long-term notes in the aggregate principal amount of up to \$20,000,000; for an exemption from the advertising and competitive bid requirements of G.L. Chapter 164, Section 15; and for such other action as may be deemed necessary or appropriate in connection with the foregoing.

Upon the foregoing application and petition, the Department of Public Utilities will conduct a public hearing in its hearing room, #1210, Leverett Saltonstall Building, 100 Cambridge Street, Boston, Massachusetts on Friday, March 24, 1989 at 10:00 A.M.

The Petitioner, Cambridge Electric Light Company, is required to give notice of said hearing by publication hereof fourteen (14) days prior to said date in the Boston Globe and the Boston Herald, and to serve a copy hereof at least fourteen (14) days prior to said date on the Mayor and City Clerk of the City of Cambridge.

The Petitioner is also required to make return of service and publication at the time of the hearing.

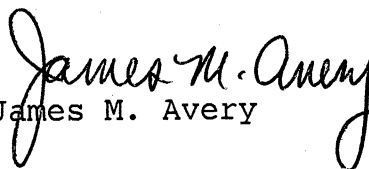
